WHY DID YOU BECOME A FREELANCE LAWYER WITH LAWCLERK?

I first became a freelancer because I was working at a nonprofit and the salary was low. I had to pay off those loans somehow! A memorandum on the immigration implications of two charged crimes for a criminal defense attorney. I really enjoy "crimmigration," which is the intersection of immigration law and criminal law. It's really unique and complicated.
